Brief Summary of Project: South Routt Middle School is seeking support in effort to restore the steps and adjacent stonework to the two main entrances to the Middle School building located in Oak Creek. The steps have deteriorated to a point where the safety of children attending the school, as well as community members accessing the building, has been put in peril. Stucco work will also be completed at the entrances to preserve the integrity of the building and protect the foundation. In addition, concrete repairs will be made to the sidewalk at the entrances. This grant request is sponsored by Historic Routt County.

8. Narrative

A. Applicant Capacity: Write a brief introduction to the applicant organization and its experience with similar projects. *This category demonstrates the applicant's ability and commitment to successfully complete the proposed project.*

The South Routt School District's mission is to *inspire every student to think, achieve, learn and care*. On an annual basis we receive 5-9 grants from large state agencies, including the Colorado Department of Education. We have met all deliverables on contracts on time for previous grant requirements including the following grant related to maintenance of the middle school: 2018 *Colorado Department of Education BEST grant for roof repair (award amount: \$214,653)*.

The District has an annual operating budget of \$5,000,000+ with a full time dedicated Director of Finance who oversees grant administration for the District. The Director of Maintenance will supervise the contractor to ensure construction work takes place according to historic standards and is completed on schedule.

This is the first historic preservation project that the District has pursued. We have sought the guidance of Historic Routt County in preparing this application and planning the project in order to educate the District about any special considerations.

The District is selective in the contractors that they work with, knowing that the investments made in the building maintenance must provide long term benefits. As a tax funded entity, we take great responsibility in stewarding our limited funds to support our mission.

The District has selected Cornerstone Masonry (Gypsum, CO) as our partner for this preservation project. The family owned business has been in operation for over thirty years and has experience with historic preservation projects. Most recently, they completed brick restoration work on a main street building in Newcastle. The work will be put into action immediately to ensure the work is complete before moisture begins to accumulate. We cannot continue to provide education to our 92 middle school students without a safe structure. The project support requested is a critical safety issue for our students and staff.

B. *Property or Project History:* Write a brief history and description of the property or a description of the project and its relationship to historic preservation. *This category tells us why this preservation project is important.*

The former Oak Creek union High, now Soroco Middle School, is located at 305 South Grant Avenue in Oak Creek, Colorado. The structure was designed by architect, Robert K. Fuller, a prominent architect who also designed the Routt Count Court House in addition to the Denver City and County Building.

The dedication of the school in 1925 marked the beginning of a new era for our little town. The building was a source of community pride because of the financial sacrifice and struggle required of early residents during original construction. Residents had struggled, worked and paid extra taxes for a larger, better-equipped and more adequately staffed school. Early on, community involvement was demonstrated as the PTA took charge of the ceremonies at the dedication of the new Oak Creek Union High. As time went on, the building was used for a variety of school and community events. There were graduations, plays, proms and sporting events that drew the entire population of Oak Creek.

It is remarkable the structure is still being used today, almost a century later, for its original purpose: education.

The school is significant to Oak Creek's history and reflects the developmental heritage and cultural characteristics of Routt County. The building is located prominently on a hilltop adjacent to Oak Creek, making it a highly visible and familiar local landmark. Compared to many of the small buildings in Oak Creek, the large two-story structure has dominated the landscape from nearly every vantage point for nearly a century. The building embodies the distinguishing characteristics of Mission Style. This formal design style is characterized by a curvilinear-shaped gable(s) with small round windows or ornaments, stucco or plaster finish and a simplicity of decoration and form.

In addition, the building site is the location of the Cavalry billets established during the 1913 coal mine strike, a prominent event in Oak Creek's history. The top of the hill was an obvious choice for their headquarters because of the view it offered for overseeing the town and its mines. From this vantage point, guns could easily be sighted on locations of anticipated violence. The presence of the Cavalry on this affected the town in two major ways. First, it provided protection for all citizens and upheld the law during the strike. Second, and equally important for future generations, it caused the State to invest funds in the area, providing the water

and sewer infrastructure to the site. This later factor eventually enabled the town to build the Oak Creek Union High School.

The historic significance and integrity of the structure earned the School designation on the Routt County Register of Historic Properties in 2000 (meeting 5 of the 10 criteria for designation). Current students attending the school have parents and grandparents who also attended school in the building. The structure is deeply rooted in the community.

C. Project Description: Provide a detailed description of the project.

This section demonstrates the appropriateness of the project and your knowledge of what is needed to complete it.

The South Routt Middle School is in need of masonry work to preserve its historic features.

Entrance Steps: The steps to both of the entrances of the South Routt Middle have come to the end of their useful life and require restoration before the start of the next school year. The project is necessary to improve the safety of the facility. School District maintenance staff have done their best to keep the stairs in working order but each winter moisture further deteriorates their condition, leading to large chunks breaking away from the stairs. There is no way of predicting when or where the stairs will break. As you will see in the attached photos, the condition of the steps is rapidly deteriorating. At times, we have had to use large orange cones to block off areas of the stairs to protect students and staff. The stairs have come to the end of their useful life. The mason will remove the existing concrete and replace the step sections with concrete to match the existing steps. The adjacent rock wall next to the concrete steps will be tuckpointing the mortar joints that have come loose. The Mason has assessed their condition and does not recommend a complete reconstruction at this time. The hand rails will be repainted.

Stucco:

The exterior of the building is stucco. Inclement weather is causing the stucco to warp and causing a break in the waterproofing seal. As a result, water is sitting at the base of the building, which could lead to a crack in the foundation. In order to refurbish the stucco the mason will remove the existing stucco, then apply a fresh stucco product. Texture and paint will be matched to the original stucco.

Sidewalk:

The sidewalk has multiple cracks, preventing easy access to the building for students and visitors in

wheelchairs. Three sections of sidewalk will be replaced with new concrete to match existing. This will allow ADA access to a third entrance with a ramp.

With the scope of work completed, the South Routt Middle School can maintain the character of the historic façade.

Appropriate professional preservation techniques will be applied throughout the project. The mason will be provided with photographs of the original structure to ensure a full restoration is accomplished.

E. Public Benefit: Tell us how/why the community supports and benefits from this project.

The South Routt Middle School continues to be a central building offering education to South Routt's students. On a daily basis, the building is occupied by 92 students and 15 staff members. The majority of all staff members reside in our community.

There are two main entrances to the school, both of which will be restored through this grant. All Middle School students enter and exit the building multiple times daily to attend music, PE and art classes in the adjacent High School Building. Students also enter and exit the Middle School daily for lunch (which is served in the High School Building).

School District use of the Middle School building includes:
Nursing office for all Middle School and High School students
Daily classroom instruction
Strings School Days musical performances
Dance performances
Concerts
School plays

Public facilities for large gatherings are limited in South Routt. As such the historic building is frequently utilized by the Oak Creek community outside of school hours. Community use of the Middle School gymnasium includes: funerals, weddings, family reunions, and indoor basketball games.

South Routt School District student enrollment has declined 25% over the last decade. Colorado's school funding is primarily allocated on a per-pupil basis. The District's budget has been strained, forcing hard decisions between instructional staff and deferring maintenance. This project should have been completed 3 years ago but has been postponed due to budget reductions. We have been saving for this project and are now ready to contribute the required match.



The District tried for weeks to secure bids from multiple contractors. This is the only bid we have at this time and feel confident in Cornerstone's ability to complete the work.











Dear MAHFAB Board,

On behalf of the Tracks & Trails Museum and Historical Society of Oak Creek & Phippsburg, I would like to extend our support for the grant application of the South Routt School District to repair the steps and stucco at the Soroco Middle School. We are thrilled to see their dedication to restore the school to standards, which reflect the honor of placement on the Historic Register.

The Middle School was formerly the Oak Creek Union High School, built in 1924. As such its historic significance and importance to the community is vivid. Often when former residents call on Oak Creek, that site is the first on the list to visit. Generations of students have attended school there and walked up those very steps of which need repair.

The building is the backdrop for countless stories and memories housed in our archives. One such story is about Marshall Clem Eller, 45 who was shot and killed in the line of duty at a school dance in 1927. The convicted perpetrator caused a disturbance and was selling bootleg liquor. In 2006, our historian, Mike Yurich submitted the information to the state, which led to Clem Eller being honored and added to the State Memorial for officers that had been killed in the line of duty. Before Mike Yurich passed away, he received notice that the National Law Enforcement Officer's Memorial Fund had honored and posted Marshal Eller's name on May 13, 2011 at their Candlelight Vigil in Washington D.C.

From dances, plays, proms, basketball games and more - even education - the school has and still continues to play a vital role in the whole of the South Routt community. I encourage you to consider this application for funding.

Dear Board Members:

The Town of Oak Creek supports the South Routt School District's application to the Museum & Heritage Fund for restoration of their front steps.

South Routt Middle School is located in the Town of Oak Creek, just a short distance from our downtown. The two-story building is historically significant to the town. It is a highly visible and familiar local landmark given its prominent location at the top of the hill. When the school first opened in 1925, the front page of *The Oak Creek Times* noted that the school evoked a sense of community pride. Since its inception, the building has been used for a variety of school and community events that drew the entire population of Oak Creek. That tradition continues to this day. The gym has hosted weddings, funerals and family reunions for generations. South Routt Middle School is one of four facilities in Oak Creek for large gatherings; as such the building gets frequent use by community members of all ages.

We share the School District's concern about the safety of the entrance steps. This past year, our first responders were called to the Middle School to respond to a medical emergency for a student having an allergic reaction. Due to disrepair of the main entrance stairs, our first responders were slowed down in their ability to access the student with a stretcher to deliver emergency care. They nearly tripped when exiting the building with the stretcher, almost dropping the student due to a disintegrated step.

Replacing the steps will give peace of mind to all who utilize the historic space. South Routt Middle School is a community gathering spot, and is so much more than a school.

As the Principal of the South Routt Middle School and High School, this letter is submitted to convey my concern for the safety of the front entrance steps at the South Routt Middle School. I believe their current condition presents a safety hazard to both students and staff.

To give you a sense of how much use the stairs are used, let me explain the daily flow of our students. The Middle School has 75 students and 15 staff members. All Middle School students enter and exit the main entrance of the Middle School building multiple times daily to attend music, PE and art classes in the adjacent High School Building. Students also enter and exit the Middle School daily for lunch (which is served in the High School Building). Most of the 100 high school students take at least on class per day in the Middle School as well. The buildings effectively function as a campus.

Our maintenance staff has done their best to keep the stairs in working order but each winter, moisture further deteriorates their condition, leading to large chunks breaking away from the stairs. There is no way of predicting when or where the stairs will break. At times, we have had to use large orange cones to block off areas of the stairs to protect students and staff.

The stairs have come to the end of their useful life. Without a safety improvement, I will not permit students to use this entrance for the coming school year. Using an alternate entrance will require a longer distance between buildings in harsh winter conditions.

We hope to continue using our historic front entrance to welcome community members, students and staff to our beautiful building. We are proud to be using the facility for its original purpose, in the spirit of the original Oak Creek Union High. The school is a historic cornerstone in our community.

Thank you in advance for your consideration of this request to support the safety of our students, staff and community.
