Routt County Looking for Public Comment on Draft Hazard Mitigation Plan

INTRO: During 2019 and early 2020, a coalition of Routt County, cities, towns, and special districts implemented a planning process to prepare for and lessen the impacts of natural hazards by updating the **Routt County Hazard Mitigation Plan (HMP)**. This partnership pooled resources to create a uniform hazard mitigation strategy that can be consistently applied throughout the Routt County planning area and will ensure eligibility for specified grant funds. The HMP includes the purpose, planning process, community engagement efforts, hazard and risk assessment, recommended local mitigation actions, and maintenance strategy for the 5-year period covered by the plan.

WHAT: Public Comments on Routt County's Hazard Mitigation Plan (HMP)

WHY: Public comment is integral for creating a comprehensive Hazard Mitigation Plan (HMP). The goal of the HMP is to identify, reduce, and prepare for the most likely hazards that may impact the residents and guests of Routt County.

- The public review period for the Draft HMP will run from June 8 - June 22, 5:00 p.m. MST
- The plan will be discussed at a virtual Routt County Planning Commission Meeting at 6:00 p.m. on **Thursday, June 11, 2020**
