

**RE: ADOPTION OF ROAD NAME**  
**Parcels in Sec3 of 6N85W**

**GIANT VIEW DRIVE**

**RECITALS**

1. Road names and addresses on roads and buildable lots in unincorporated Routt County are to be assigned pursuant to the Routt County Requirements for Addressing (the "Addressing Requirements") adopted January 16, 1996, and revised September 27, 2011.
2. The intent of the Addressing Requirements states “To establish and maintain a system for the assignment, naming and identification of roads and numerical addresses for unincorporated Routt County which will improve the efficiency of locating a property by use of a unique street name and address.”
3. According to the Addressing Requirements; every road existing, proposed, or constructed which provides, will provide, or is proposed to provide access to two or more buildable lots, as defined in the Routt County Zoning Resolution, and in unincorporated Routt County, shall be identified with a unique road name so as to clearly identify and distinguish such road from every other road in Routt County.
4. It has been determined by the Routt County GIS Department that the road name process must be followed for a private road accessing parcels in Sec3 of 6N85W. The locations of the lots are shown on the drawing attached hereto as Exhibit A.
5. The Routt County Board of County Commissioners held a public hearing in accordance with the Addressing Requirements for the purpose of assigning the new road name as described above.

**NOW THEREFORE BE IT RESOLVED** by the Routt County Board of County Commissioners that the road shown in Exhibit A, all in Sec3 of 6N85W, shall be named GIANT VIEW DRIVE from its intersection of County Road 42, to its terminus as illustrated in Exhibit A.

**BE IT FURTHER RESOLVED**, that road sign bearing the name approved herein and addresses assigned to the structures shall be posted in accordance with the Routt County Requirements for Addressing.
