V. BACKGROUND INFORMATION:

It has been a little more than two years since the Facilities Management Department merged with the Road & Bridge Department; the merger created the Public Works Department.

The Facilities Management Department was formed in late 2017 when the Building & Plant/Purchasing/Fairgrounds/Custodial Department was reorganized following the retirement of the department director.

The Purchasing function became a standalone Purchasing Department overseen by the Deputy County Manager, and the Building & Plant, Fairgrounds and Custodial functional areas were renamed the Facilities Management Department.

The Facilities Management and Road & Bridge departments remain as separate functional areas and operate under the direction of the Public Works Director.

The workload within Facilities Management is steadily increasing, and the current staffing levels and position levels are not adequate to meet the demands placed on the department and director. Work demands are increasing, in part, because of aging facilities, increased number of facilities, increased use of county buildings, expansion of services and amenities at the Fairgrounds, large projects such as the CLEF, employee security concerns, and the need to create more financially and environmentally sustainable facilities.

The proposed personnel addition will benefit all functional areas within the Public Works Department.

The Routt County 2020 Budget includes the salary for the addition of a fulltime position in the Public Works Department.
