The Routt County Motor Pool Project Manager requested Colorado State Bid Pricing from Larry H. Miller Dodge Jeep Ram for 4 new 2020 model vehicles for current motor pool vehicles scheduled for replacement:

All vehicles include \$350 per vehicle for FOB Destination charges and full manufacturer warranty. The remainder of the Sheriff Office vehicles budget will be consumed for the additional equipment necessary and provided by a separate vendor.
