I. DESCRIBE THE REQUEST OR ISSUE:

Consideration for approval and authorization for the Chair to sign the Contract Agreement between Routt County and FCI Constructors, Inc. for the YVRA terminal expansion project scheduled for construction starting 1 May 20 and completion NLT 30 Nov 20. This contract is for the execution of AIP Project No. 3-08-0031-047048; the four schedules included in this project bring the total AIP-funded project contract cost to \$3,235,000. In addition to this AIP-funded cost YVRA is contracting FCI to complete needed HVAC work upstairs in the terminal office areas at a total cost of \$100,500; this Alternate Bid Item 1 is not eligible for AIP funding and will be funded from YVRA reserves. The Notice to Proceed will be ready for signature as soon as the FAA completes their AIP-48 grant processing and issuance; FAA estimates this grant will be issued within 2-3 weeks.

II. RECOMMENDED ACTION:

Approval and authorization for Commissioner Corrigan to sign the contract agreements (3 originals) between Routt County and FCI Constructors, Inc. for the YVRA terminal expansion project.

PROPOSED EXPENDITURE: \$162K YVRA local match for this contract; does not include the Mead & Hunt engineering and architectural consultant's fees which are covered under a separate contract amendment.
