Monger, Deputy County Manager Dan Weinheimer, and County Manager Tom Sullivan were also present. Those present recited the Pledge of Allegiance. Deanna Sanchez recorded the meeting and prepared the minutes. Commissioner Tim V. Corrigan was absent.

Ray DuBois, Public Works Director, and Tiffany Carlson, Weed Program Supervisor were also present.

REVISIONS TO NOXIOUS WEEDS LIST

Mr. Brown stated his request for approval of the revisions to the current Routt County Weed Management Plans Noxious Weeds list. The proposed revision includes the addition of three invasive weeds that will create negative impacts to Routt County landscapes if not monitored and controlled. The additions would include curly dock (*Rumex Crispus*) and common mullein (*Verbascum Thapsus*) to the current 13 weeds and bulbous bluegrass (*Poa Bulbosa*) as

a species of concern. Bulbous Bluegrass will have a separate designation as a species of concern because there currently are no known feasibly acceptable treatments for this species.

Mr. Brown, Ms. Carlson, Mr. DuBois, and the Commissioners discussed the request.

MOTION

Commissioner Monger moved to approve the additions to the Routt County Weed Management Plan Noxious Weeds list as Curly Dock (*Rumex Crispus*) and Common Mullein (*Verbascum Thapsus*) to the current 13 weeds and Bulbous Bluegrass (*Poa Bulbosa*) as a species of concern

CONSIDERATION TO APPROVE THE PUBLIC HEALTH ADMINISTRATIVE SPECIALIST PAY SCALE

Ms. Nelson stated Kari Ladrow, Director of Public Health, is requesting to add a Public Health Administrative Specialist position. This position reports directly to the Public Health Director and under general supervision, will provide complex administrative support to the Department. This will be a full-time benefitted position.

Ms. Nelson has evaluated the job description against Employers Council salary information and benchmarked it against an Administrative Assistant III utilizing resort salary data. She also reviewed the position against the County's job evaluation factors and the job description meets the point factor of an Administrative Assistant IV pay scale. The County Manager has reviewed this request and approved placing this request on the agenda for your consideration and approval.
